### **Matheson Residents 2016-2017 Package**



Guide  
lines:

- Participants must be 60 years of age and older to use the transportation service.



- There will be no special arrangements made for pickups or drop offs.
- All participants must confirm their attendance prior to the transportation service being provided. See transportation schedule for confirmation dates.
- Only participants who have confirmed their attendance and signed the liability waiver will be allowed to use the service. The driver will not allow anyone on the bus if their name is not on the attendance sheet.
- If the participant must cancel their attendance for one of the scheduled pickups, a 24 hr notice is required.
- A minimum of 10 participants will be required to provide the service for that respective date. If there are not enough participants by the confirmation date, the service for that day will be cancelled. Participants who did confirm their attendance will receive notification from the municipality.
- Participants must be reasonable in the amount of shopping bags brought back to the bus.
- Beverages are allowed on the bus.
- Snacks are permitted in small quantities.
- Advise the municipal office when calling in your attendance if you have a walker or cane.
- Any changes made to the schedule will be posted on our website and at the pickup/ drop off locations.
- Due to weather conditions, the scheduled pickup day may be cancelled. This decision will be at the discretion of Leuschen Transportation. All seniors scheduled for pickup for that day will be notified as soon as possible.
- The Community Transportation Grant will end on March 31, 2017. Your feedback on the program is appreciated.
