**BY-LAW NO. 2019-05**

**BEING A BY-LAW** TO AMEND BY-LAW 2018-14, OF THE CORPORATION OF THE TOWNSHIP OF BLACK RIVER-MATHESON

---

**WHEREAS** the Council of the Corporation of the Township of Black River-Matheson is desirous of amending Bylaw 2018-14, being a by-law authorize the levying of solid waste fees and charges.

**NOW THEREFORE** the Council of the Corporation of the Township of Black River-Matheson **ENACTS AS FOLLOWS:**

1. That Sections 10, 11 and 12 are hereby repealed.
2. That Section 13 is hereby repealed and a new Section 10 be added:
  10. That By-law No. 2017-09 is hereby repealed.
3. That bag tags be removed from Schedule "A" of By-law 2018-14 and replaced with:

Tags	Free Loads	2 free tags/year
------	------------	------------------

This by-law shall come into force and take effect on the date of the final passing thereof.

CORPORATION OF THE TOWNSHIP OF BLACK RIVER-MATHESON

BY-LAW NO. 2018-14

A BY-LAW TO AUTHORIZE THE LEVYING OF SOLID WASTE FEES AND CHARGES

---

WHEREAS the Municipal Act, 2001 S.O. 2001, c.25, as amended, provides that the council of a local municipality may pass by-laws to impose fees and charges on any class of persons;

THEREFORE the Council of the Corporation of the Township of Black River-Matheson ENACTS AS FOLLOWS:

1. In this by-law, the following words shall be defined as:

**PROPERTY OWNER(S)** means the person(s) whose name(s) is (are) registered in the municipal assessment roll.

**SEASONAL RESIDENTIAL HOUSEHOLD** means a dwelling unit used as a secondary place of residence for seasonal vacation and recreational purposes and is principal residence of the owner(s) for a period of not less than eight (8) consecutive weeks per calendar year. This does not include a hunt camp and/or trailer.


**PRINCIPAL RESIDENTIAL HOUSEHOLD** means a dwelling unit used as a primary place of residence. This does not include a hunt camp and/or trailer.

2. That the solid waste rates for garbage collection provided by this by-law take precedence over any similar rates provided in any other by-laws.
3. Solid waste rates for garbage collection shall be as set out in Schedule "A" to this by-law.
4. The rates established shall be billable in four (4) installments and collected as the charge for the collection of solid waste to each year.
5. The following collection charges shall apply:
  - i. The Treasurer no later than 21 days prior to the date the payment is due, shall mail or cause to be mailed the notice of solid waste collection to the ratepayer.
  - ii. Penalty for non-payment in whole or in part shall be added to the account on the first day of default and one the first day of each month thereafter on any outstanding amount at the rate of 1.25%
  - iii. As per the Municipal Act, any accounts in arrears of solid waste collection may be added to the collector's roll.
6. That solid waste collection accounts may be paid through the following facilities:
  - Township of Black River-Matheson Municipal Office, 429 Park Lane, Matheson, ON

- Preauthorized Payment plan
- Mail service via Canada Post
- Telebanking and internet services through most major financial institutes
- By cash, cheque, money order, debit or credit (Visa/Mastercard)

7. The Treasurer is hereby empowered to accept part payment from time to time on account of solid waste collection due.
8. These rates have been established to raise the revenues required to meet the expenditures for solid waste collection services.
9. These rates shall continue to be in effect until such time as the municipality adjusts the rates.
10. Bag tags will be available at the beginning of each calendar year to the property owner only. If the dwelling is a rental unit(s), it is the property owner's responsibility to distribute the bag tags to the tenant(s).
11. If there is a property ownership change during the calendar year, it is the original property owner's responsibility to transfer the bag tags to the new owner. If the previous owner did not transfer the bag tags and the property owner is a new resident of the municipality, the municipality will provide bag tags on a pro-rated basis from the date the ownership change to the respective year end.
12. If a property owner has a principal and secondary residential household within the jurisdiction of Black River-Matheson, they will only receive tags for the principal household.
13. That By-law No. 2017-09 is hereby repealed.
