TAKE NOTICE THAT the Planning Advisory Committee of the Corporation of the Township of Black River-Matheson will hold a public meeting on Thursday, May 16, 2019 at 3:00 p.m. in the Council Chambers, 429 Park Lane, Matheson to gather public input regarding a proposed Zoning By-law Amendment under Section 34 of the Planning Act, R.S.O. 1990, C.P. 13, as amended.

Purpose and Effect of Zoning By-law Amendment:

To amend By-law No. 2016-31, being the Comprehensive Zoning By-law for the Township of Black River-Matheson, by rezoning a portion of the subject property from Rural "RU" to Institutional "I", in order to permit the construction of a church and to fulfill the conditions of the consent (C2019-01) as set out by the Planning Advisory Committee. Any person or public body may attend the public meeting and/or make written or verbal representation either in support of or in opposition to the proposed Zoning By-law Amendment.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Black River-Matheson before the proposed Zoning By-law Amendment is passed, the person or public body is not entitled to appeal the decision of the approval authority to the Local Planning Appeal Tribunal.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Black River-Matheson before the proposed Zoning By-law Amendment is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

A copy of the proposed Zoning By-law Amendment and information and material related to the amendment will be available for inspection at the Municipal Office during regular office hours.
